By email dated February 27, 2014 (copy attached to this order), Össur requested a conference call to discuss authorization to file supplemental information consisting of papers from an appeal to the U.S. Court of Appeals for the Federal Circuit (Fed. Cir. No. 13-1650) from the related civil action, *Otto Bock HealthCare LP v. Össur Hf et al.*, No. SACV13-00891-CJC (C.D. Cal.). In particular, Össur seeks to file Otto Bock's Reply Brief, the transcript of the hearing before the Federal Circuit, and the Federal Circuit's decision (as modified by an errata sheet). Össur explained that the new information supplements Exhibits 1034 and 1035 as filed with the Petition. Otto Bock has no objection to the submissions.

Upon consideration, the Board denied Össur authorization to file any of the proposed information as supplementation to Exhibits 1034 and 1035, because Össur relies upon Exhibit 1034 in its Petition only as evidence for an issue not in dispute and does not rely at all upon Exhibit 1035.

The Board, nevertheless, recognizes the potential relevance of the Federal Circuit's decision on the issue of claim construction.

Accordingly, it is

ORDERED that Össur is authorized to file a copy of the decision, with the errata sheet, in *Otto Bock HealthCare LP v. Össur Hf et al.*, No. 13-1650 (Fed. Cir.).
